The ocean produces half of the oxygen on Earth and yet it is in danger. Given the urgency of this, Surfrider Foundation Europe has developed a major campaign of citizen mobilization, ahead of the European elections to be held in 2019.

The Voice for the Ocean campaign offers European citizens, whether they are students, experts or ocean lovers, the opportunity to express their visions and priorities regarding the protection of the oceans. These will be compiled and analyzed by Surfrider who will then make these demands as part of the campaign for the European elections.

... COUPLED WITH A EUROPEAN TOUR TO MEET VARIOUS AUDIENCES

In addition to this consultation, Surfrider has also developed a European tour to meet various audiences: schoolchildren, committed citizens, scientists, local, national, and European elected representatives, etc., that is to say a lot of citizens involved in the protection of the oceans, for whom it will be possible get information, discuss and express oneself.

Each stage of this Voice for the Ocean tour will be organized hand in hand with local actors or subject matter experts. Five stages are already planned (in Bulgaria, France, Spain, Belgium and Portugal).



The first stage in Burgas, Bulgaria, on the occasion of the European Maritime Days, will be the occasion for Surfrider to officially reveals this new campaign, and thus to reaffirm the NGO's commitment to make oceans a question policy at the national, European and international levels.
